

b. In accordance with New York State General Municipal Law 109, at no time during the duration of the Contract, shall the Successful bidder be allowed to assign any portion of this Contract to a third party without prior written consent of the District.

(V) Extension of Contract to Political Subdivisions -

The Sachem Central School District reserves the right to allow all municipal, not-for-profit and political subdivisions authorized under the General Municipal Laws of the State of New York, to purchase any goods and/or services awarded as a result of this bid in accordance with the latest amendments to NYS GML 100 through 104. However, it is understood that the extension of such contracts are at the discretion of the vendor and the vendor is only bound to any contract between the Sachem Central School District and the vendor.
